## Section II. INSTRUCTION TO BIDDERS (ITB)

A. GENERAL PROVIS	SIONS
1. Introduction	1.1 Bidders shall adhere to all the requirements of this ITB, including any amendments made in writing by IHVN. This ITB is conducted in accordance with International Standard Practice.
	1.2 Any Bid submitted will be regarded as an offer by the Bidder and does not
	constitute or imply the acceptance of the Bid by IHVN. The Institute is under no obligation to award a contract to any Bidder as a result of this ITB.
	1.3 IHVN reserves the right to cancel the procurement process at any stage without any liability of any kind for IHVN, upon notice to the bidders or publication of cancellation notice on IHVN website.
	1.4 As part of the bid, it is desired that the Bidder registers with the Institute through the legal unit. The Bidder may still submit a bid even if not registered with the Institute. However, if the Bidder is selected for contract award, the Bidder must register with IHVN prior to contract signature.
2. Fraud & Corruption, Gifts and Hospitality	<ul> <li>2.1 IHVN strictly enforces a policy of zero tolerance on proscribed practices, including fraud, corruption, collusion, unethical or unprofessional practices, and obstruction of IHVN vendors and requires all bidders/vendors to observe the highest standard of ethics during the procurement process and contract implementation.</li> <li>IHVN's Anti-Fraud email: <u>speakout@ihvnigeria.org</u> can be reached at all times to report any foul play at any level.</li> </ul>

		4.2	In the event of any uncertainty in the interpretation of a potential conflict of interest, Bidders must disclose to IHVN, and seek the Institute's confirmation on whether or not such conflict exists.

### Section IV. EVALUATION AND QUALIFICATION CRITERIA

# Evaluation criteria will be done at three different levels, which are: preliminary evaluation, technical evaluation and financial evaluation.

Contract will be awarded to the bidder with the least cost, who has also been considered responsive to both preliminary and technical evaluations.

Possible cross discounts (price discounts) will be taken into account. These cross discounts will be indicated on the contract final total.

Technical evaluation would be done by IHVN technical team, using the brand and type of the equipment and a leaflet (documentation) of the equipment submitted by the bidders.

All other criteria stated below are to be considered as pass / fail.

### Section VI Schedule of Requirements

#### 1. Description of the installation.

The purpose of this project is to provide and install a full standalone off-grid system and the circuit interconnection of the various components.

The project entails the installation of a stand-alone, off grid power system and attendant accessories to optimize the thru put of the lab. The off-grid power system operates on the principle of converting captured energy from sunlight and its conversion to AC power for use by the equipment within the lab. The running equipment include GenExpert modules, workstation, refrigerator, air conditioning unit, and light points. It is expected that power supply to the lab will be 'Self-sustaining' with little or no maintenance.

An alternate connection to mains is ensured but left open as a back-up for maintenance periods.


Each location (see Section X) will be provided with the same equipment and interconnections.

- a) Solar panels of minimum ± 300 Watts each and with a total array capacity of a minimum 5,400 Watts need to be installed on an assembled array frame that is anchored to a solid concrete base (to be constructed by the contractor).
- b) The panels are connected to Inverter batteries, situated reasonably close to the solar panels. The batteries are arranged in banks in line with the inverter voltage rating.
- c) The batteries will also be placed in a compact built battery rack that is lockable and allows for easy aeration, to be placed either on the concrete base, or within the lab, inside a protective box (but still allowing easy access).
- d) A charge controller regulates and controls the charging current required by the batteries and the DC charging power from the solar panels.
- e) The inverter converts DC power from the batteries to AC power required to operate most of the lab equipment.

It is a full control equipment such that it ensures management of the power from the inverter batteries, converts cycles, maintains cut off thresholds that relates to the capacity of attached load (lab equipment).

- f) A 'Grounding' system planted to protect the installation by diverting unwanted voltages to ground.
- g) Breakers are connected at input lines, or output lines to devices to ensure for manual isolation of these devices when necessary.
- h) The distribution-panel for the essential circuits is in principle only connected to the inverter. But provision is made for a redirection to alternate power supply when necessary via a changeover switch. Here an automatic voltage regulator will interface the alternate input power (Public grid or Private generator) to the distribution panel.
- i) Manuals for all installed items must be made available and must be in the English language.
- j) All items to be supplied and installed by the supplier.
