COMMUNIQUÉ OF THE 2025 EXCEL RITE CONFERENCE

On Exploring Excellence In Collaboration, Ethical Conduct, And Leadership For Research Integrity Through Empowerment

JULY, 2025









Preamble

The EXCEL RITE Conference — Exploring Excellence in Collaboration, Ethical Conduct, and Leadership for Research Integrity Through Empowerment — was convened from April 28th to 30th, 2025, at the Institute of Human Virology Nigeria (IHVN), Abuja. Jointly organised by IHVN and the National Health Research Ethics Committee (NHREC), it brought together over 300 stakeholders, including the leadership and representatives from NAFDAC, the Federal Ministry of Health, the Federal Ministry of Health and Social Welfare, academics, government officials, development partners, and students.

The conference provided a strategic platform to examine Nigeria's research integrity landscape, identify critical gaps, and develop sustainable institutional and national frameworks that promote responsible conduct of research.

Objectives

- 1. **Develop** and strengthen national and institutional frameworks for research ethics and research integrity.
- 2. **Enhance** the ethical competence and capacity of researchers, ethics committees, and institutions.
- 3. **Foster** multi-sectoral collaboration and shared ownership of ethical research practices in Nigeria.
- 4. **Initiate** discussions to generate actionable recommendations for an effective research policy and guidelines development for research Integrity.
- 5. **Advocate** for the institutionalisation of Research Integrity in Nigeria.





Day 1 | Building Foundations for Ethical Research

- Anecdotal reports of unaddressed or poorly managed authorship problems in scholarly communications at our higher institutions.
- NHREC's operational capacity remains limited due to long-term underfunding, affecting oversight, licensing, and state, regional and institutional HREC coordination in Nigeria.
- The poor administrative infrastructure of research ethics across Nigeria impedes the ability to enforce ethical standards nationwide.
- Institutional monitoring systems for Health Research Ethics Committees (HRECs) are lacking in many institutions.
- Poor knowledge, awareness and collaboration among researchers on research integrity in Nigeria.





Day 2 Ethical Capacity and Structural Reform

- Competence gaps in ethical review persist, and many state-level HRECs lack websites or public accountability mechanisms.
- NHREC, State HRECs and regional HRECs lack the infrastructure and resources
 to build and maintain ethical integrity and ensure the responsible conduct of
 research at national and regional levels.
- Inadequate institutional structures cannot prevent issues such as plagiarism, publication and ethical misconduct from happening.
- Need to scale up and sustain the recently acquired NHREC IT portal for protocol application and submission. Ownership and sustenance by the government are much needed.
- Streamlining Nigeria's research ethics code, policy documents and guidance for easy use, accessibility, and detailed guidance and information is an important step
- A lack of independent funding of HRECs in states, regions and academic institutions in Nigeria alters their function, immunity from bias, institutional leadership control and political influence.
- Lack of career pathways and investment in the field of ethics and research integrity in Nigeria make it largely unattractive to young professionals and keep it from reaching its potential.





Day 3 | Collaboration and Commitments for the Future

- IHVN pledged to support NHREC to train 100 personnel active in the field of research ethics from the six geopolitical regions in Nigeria in Research ethics and research integrity within a one-year time frame.
- A sustained national advocacy campaign to create awareness on the need and the importance of a strong and effective research governance to support the nation's efforts in research ethics and research integrity will be launched. This advocacy will be supported/driven by NHREC in collaboration with IHVN.
- The EXCEL RITE leadership will undertake engagement with the relevant government ministries and agencies to advocate for the positive changes we want to see and close the gaps noted in the conference consensus by visiting the following:

Conference Consensus

- Institutions should adopt formal authorship policies with authorship roles clearly defined at the start of each research project. The practice of gift authorship, retrospective approvals, and denial of credit to junior researchers—especially students—must be discouraged. Clear policies and sanctions are needed.
- NHREC, state, regional and institutional HRECs should be restructured and resourced to grow a sustainable ethics infrastructure in Nigeria. Institutions must synergise to support, advocate and sustain initiatives and policies developed by NHREC and relevant stakeholders to build Research Integrity and research ethics in Nigeria.
- A formal Research Integrity/ Responsible Conduct of Research framework should be established/institutionalised in all tertiary institutions in Nigeria to address research misconduct, questionable research practices and foster a culture of responsible research.
- NHREC's new IT portal—recently funded by the US CDC and Gates Foundation—will improve operations through online protocol submissions and tracking; however, country ownership and sustained funding are needed for scale-up and sustainability.



- Nigeria's National Ethics Code should be redesigned as a standalone policy with detailed guidelines to enhance usability and implementation.
- Institutional Ethics Committees should be allowed/encouraged to receive/attract independent funding outside of Internally Generated Revenue (IGR) controls.
- Career pathways in research ethics and research integrity through investment from government and private partnerships should be formalised, drawing on international best practices in developed countries such as the US and the EU to develop a critical mass of experts who will support sustainable innovation and development in the field of research ethics/research integrity in Nigeria.

Participants underscored the urgent need for robust leadership, collaboration, national commitment, and sustainable financing to reposition Nigeria's research environment and to address the perennial lack of effective research policies and guidelines.
